[REDACTED] AMENDED JUDGMENT

The Ninth Circuit Court of Appeals affirmed in part, reversed in part, and remanded Part "A" of this multidistrict overtime pay litigation for further proceedings. See In re Farmers Ins. Exchange, Claims Represent., 481 F.3d 1119 (9th Cir. 2007). The proceedings on remand are complete, and in accordance with the Opinion and Order entered on October 28, 2008, and the Court's letter to Counsel of January 8, 2009, it is HEREBY ORDERED AND ADJUDGED as follows:

1. Judgment is entered in favor of defendant Farmers Insurance Exchange ("FIE") and against plaintiffs on plaintiffs' Fair Labor Standards Act overtime claims;
2. Judgment is entered in favor of FIE and against all Washington class member claims representatives on their Washington state law overtime claims;
3. Judgment is entered in favor of FIE and against all Oregon Liability, Property, Foremost, and Multiline class member claims representatives on their Oregon state law overtime claims;


PAGE 1 - [REDACTED] AMENDED JUDGMENT

4. Judgment is entered in favor of the Oregon APD class member claims representatives and against FIE on the Oregon APD claims representatives' Oregon state law overtime claims in the amount of \$3,259,378.87, to be apportioned as set forth in Exhibit A attached hereto;

5. The state law claims of the Colorado, Minnesota, New Mexico, and Illinois class member claims representatives are DISMISSED for lack of subject matter jurisdiction.

This judgment terminates all proceedings in MDL-33-1439(A). Any other pending motions with respect to part "A" are denied as moot.
